Reve's resolve strengthens through a candid conversation with Jazzy, who encourages her to be bold about her feelings for Jacob. With her sister's encouragement, Reve decides to take action. At Jazzy's Joint, her nightclub,





she seizes her chance during an unexpected confrontation with another woman's advances on Jacob. Asserting herself with newfound confidence, she proclaims Jacob as her man, surprising even herself.

Jacob's reaction is a mix of surprise and gratification, yet he momentarily withdraws on the dance floor, leaving Reve questioning the risk she took. However, with a strategic move to a jukebox, Jacob sets the tone with a Patsy Cline ballad. As the music envelops them, an unspoken understanding passes between them, reigniting the connection that seemed lost but was never truly gone. They find solace and renewed love in each other's arms, dancing together as the world fades away, leaving only the warmth of their bond.
