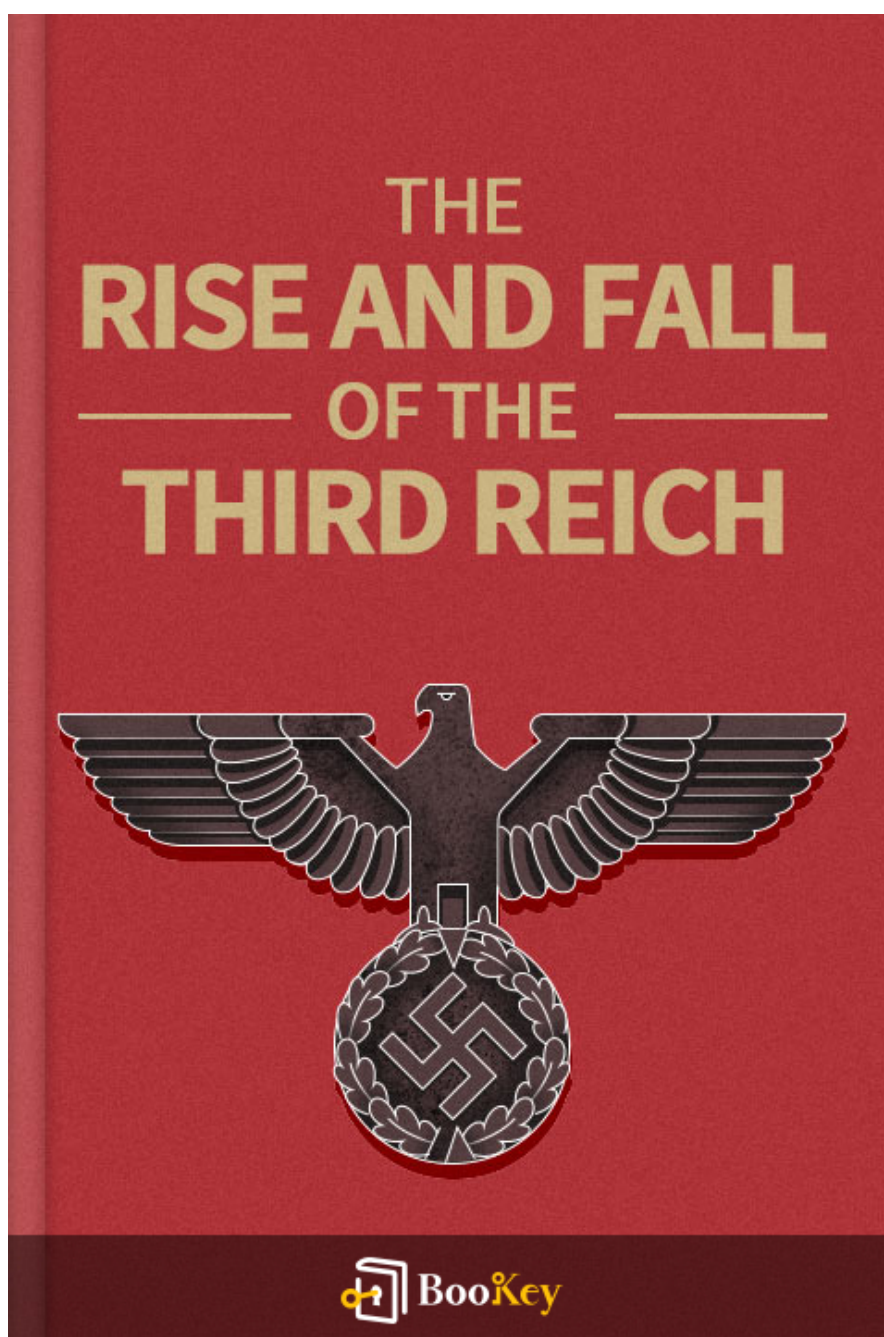

disrupted those of the Social Democrats. Despite the terror tactics employed, Hitler's party won only 44% of the vote, falling short of a complete majority. Nevertheless, by aligning with nationalist parties, the Nazis managed a slight majority in parliament.

Hitler's greater scheme was to pass an "Enabling Act," which would grant his cabinet full legislative powers for four years, effectively sidelining the Reichstag and the Presidency. On March 23, with Communist members banned and some Social Democrat deputies detained, the Act passed. Armed with parliamentary support (except from the defiant Social Democrats), Hitler now wielded dictatorial powers in Germany.

With the Enabling Act, Hitler dismantled Germany's democratic institutions through a process called Gleichschaltung ("coordination"). The states lost their powers, trade unions dissolved, and political parties, even Hitler's allies, were disbanded. By midsummer 1934, the Nazi Party was the sole political organization in Germany; democracy had been extinguished.

However, internal challenges lingered. Ernst Röhm and his S.A., with their radical socialist ideas and ambition to become the new German army, posed a threat. The traditional military, which Hitler needed for support, opposed the S.A.'s aspirations. The Army's support became more vital as President Hindenburg's health declined, and Hitler needed its backing to ensure his succession.



By June 1934, tensions peaked. Röhm and many S.A. leaders were demanding a "second revolution" to fulfill their goals. Facing pressure from Hindenburg and the Army, Hitler saw Röhm's ambitions as unsustainable. 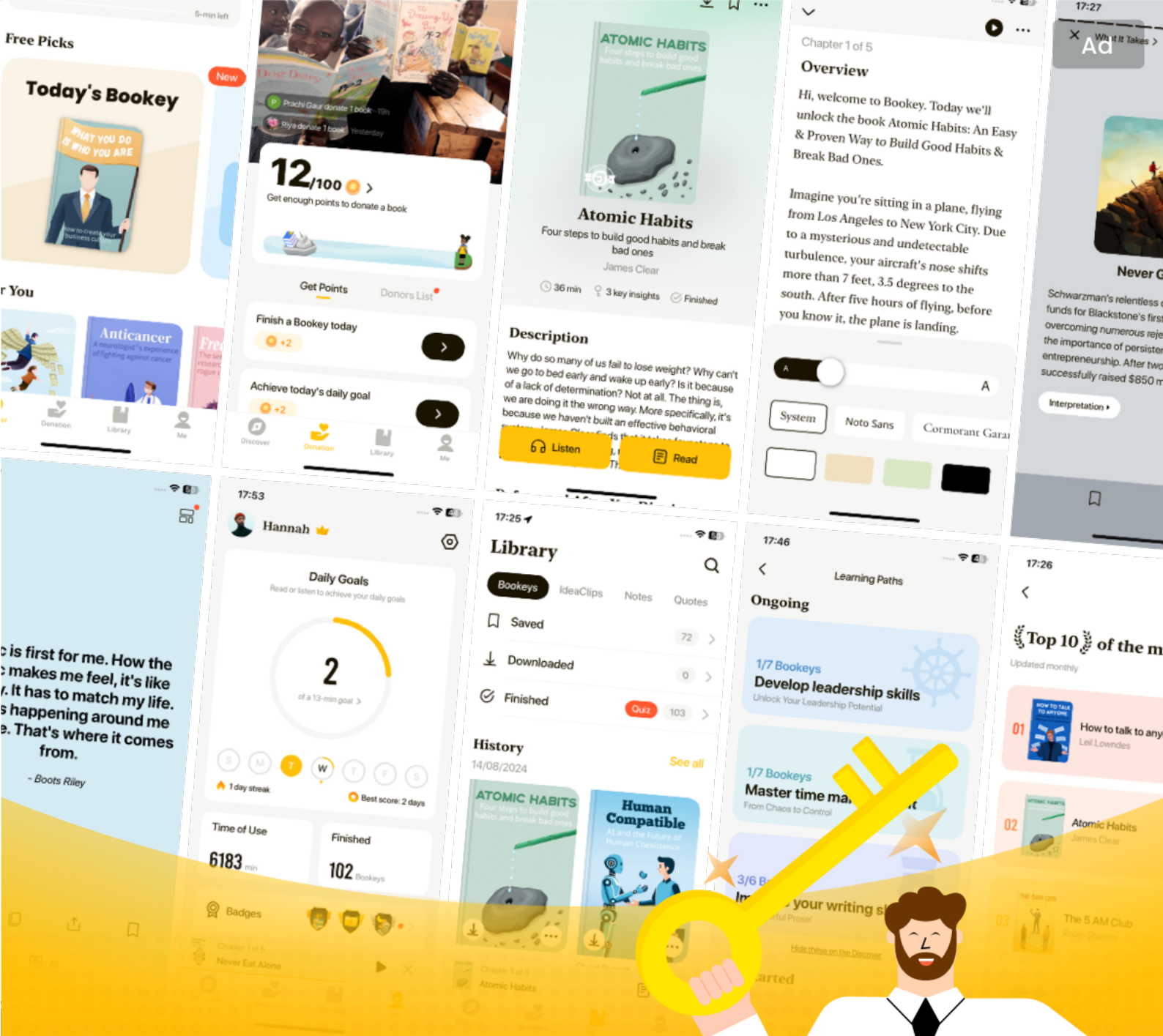

On April 30, after a small wedding ceremony with Eva Braun, Hitler and his new wife committed suicide. Their bodies were burned in the Chancellery garden to prevent them from falling into enemy hands, as Hitler refused to become a spectacle like Mussolini, who had been executed and desecrated by Italian partisans days earlier.

With Hitler gone, the end of the Third Reich was imminent. Goebbels, determined to follow Hitler's fate, orchestrated the murder of his children before he and his wife committed suicide. Bormann attempted an escape but



likely died soon after, leaving the Third Reich to crumble.

On May 1, Admiral Doenitz broadcast a message announcing Hitler's death while perpetuating the myth of his “heroic” end. Still, with both military defeat and internal betrayal complete, Germany agreed to unconditional surrender on May 7, 1945, officially ending the Third Reich and marking the long-awaited cessation of hostilities in Europe. By May 8, the guns of war fell silent, concluding more than five years of devastating conflict that left Europe in ruins and millions dead. The fall of the Third Reich marked a dramatic end to the distorted vision of Hitler's Thousand-Year Reich, leaving Germany in a state of occupation and devastation.
